#### **ORDINANCE NO. 2018-04**

AN ORDINANCE SETTING PRICES AND FEES RELATING TO LEBANON
JUNCTION CITY CEMETERY, AND SETTING A TIME LIMIT OF ONE YEAR TO
INSTALL HEADSTONES OR OTHER PERMANENT MARKERS.

WHEREAS prices and fees relating to the Lebanon Junction City Cemetery have not previously been set by ordinance, and

WHEREAS a time limit for the installment of headstones or other permanent markers in the Lebanon Junction City Cemetery has not previously been set by ordinance, and

WHEREAS the City Council of the City of Lebanon Junction has determined that it is in the public interest that such prices, fees, and time limit should be set by ordinance,

BE IT ORDAINED BY THE CITY OF LEBANON JUNCTION, BULLITT COUNTY, KENTUCKY:

SECTION ONE: "Double Deep" Definition, Area, Prices and Fees

- (a) "Double deep" interments involve the potential interment of two persons, the cremains of two persons, or of one person and the cremains of another person, within one grave plot with the first interment to be at sufficient depth that a second interment may be done above the first at the usual depth of a single, non-"double deep" interment.
- (b) Grave plots approved for use for "double deep" interments may be located within the Lebanon Junction City Cemetery only to the northern-most side of Rudd Avenue.
- (c) The following are the prices and fees for "double deep" approved grave plots and interments:

- For purchase of the use of a grave plot which is approved to be used for "double deep" interments:
   Seven-Hundred Fifty Dollars (\$750.00)
- 2. For the first interment in a grave plot approved for "double deep" interments, whether of cremains, of a person less than one year of age on the date of their death, or of a person one year of age or more on the date of their death, such that another interment above the first may be made within that same grave plot:

One-Thousand Dollars (\$1,000.00)

3. For the second interment in a grave plot approved for "double deep" interments, or for a non-"double deep" interment in a grave plot which is approved for "double deep" interments but which the purchaser has determined not to use for "double deep" interments, the prices and fees are the same as for non-"double deep" interments set out in Section Two, Subsections (b)(2), (3) and (4), below.

SECTION TWO: Non-"Double Deep", Area, Prices and Fees

- (a) Grave plots not approved for use for "double deep" interments may be located within the Lebanon Junction City Cemetery to either side of Rudd Avenue.
- (b) The following are the prices and fees for non-"double deep" approved grave plots and interments and for second interments in "double deep" approved grave plots:
  - For purchase of the use of a grave plot which is not approved to be used for "double deep" interments:
     Seven-Hundred Fifty Dollars (\$750.00)
  - 2. For interment of cremains: Two-Hundred Dollars (200.00)
  - 3. For interment of a person less than one (1) year of age on their date of death:

Two-Hundred Dollars (\$200.00)

4. For interment of a person one (1) year of age or more on their date of death:

Seven-Hundred Fifty Dollars (\$750.00)

SECTION THREE: Any headstone or other permanent marker to be installed marking a deceased person's burial place, or the burial place of their cremains, within Lebanon Junction City Cemetery must be permanently fixed in its final position within one (1) year of the deceased person's, or the deceased person's cremains', interment.

<u>SECTION FOUR</u>: This Ordinance shall be effective upon publication.

<u>SECTION FIVE</u>: Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

<u>SECTION SIX</u>: Parts of any ordinances in conflict with this Ordinance are hereby repealed.



# CITY OF LEBANON JUNCTION ORDINANCE NO. 2020-07

### Amending Ordinance No. 2018-04

AN ORDINANCE AMENDING ORDINANCE NO 2018-04 RELATING TO SETTING PRICES AND FEES RELATING TO LEBANON JUNCTION CITY CEMETERY, AND SETTING A TIME LIMIT OF ONE YEAR TO INSTALL HEADSTONES OR OTHER PERMANENT MARKERS

WHEREAS, the City Council of the City of Lebanon Junction did adopt Ordinance No. 2018-04 setting prices and fees for and establishing regulations with respect to headstones related to the Lebanon Junction City Cemetery; and

WHEREAS, from time to time it becomes necessary to amend such regulations to provide for the proper maintenance and safety of the Lebanon Junction City Cemetery and to ensure the effective and efficient operation of the Cemetery; and

WHEREAS, the City Council has determined it is in the best interests of the public to amend the regulations of the Cemetery.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEBANON JUNCTION, BULLITT COUNTY, COMMONWEALTH OF KENTUCKY:

## SECTION ONE: HEADSTONES OR OTHER PERMANENT MARKERS

Ordinance No. 2018-04, <u>Section Three</u> is amended by adding at the conclusion of Section Three the additional regulation as follows:

A base shall be constructed for each headstone or other permanent marker to be installed pursuant to the following specifications as demonstrated by the attached drawing, which is incorporated by reference and adopted as if set out herein. There shall be two (2) concrete legs at least sixteen inches (16") deep and eight inches (8") in diameter with twenty four inch (24") long Rebar inserted in each leg. An eight inch (8") thick concrete base shall be centered and poured on top of the legs and penetrated by the Rebar. The base shall be two inches (2") wider and longer than the headstone or other permanent marker to be installed thereto. Prior to pouring any concrete for the base, any person shall contact Lebanon Junction City Hall (502-833-4311) to request an inspection.

## SECTION TWO: REMAINDER OF ORDINANCE 2018-04 UNAFFECTED

The rest and remainder of Ordinance No. 2018-04 not amended herein shall not be affected by this Ordinance and shall remain in full force and effect.

### **SECTION THREE: SEVERABILITY**

The provisions of this Ordinance shall be severable. Should any section, subdivision, sentence or clause of this Ordinance be held unconstitutional or invalid for any reason by any court of competent jurisdiction, then such portion shall be deemed a separate, distinct and independent provision and such holdings shall not affect the validity of the remaining portions of this Ordinance.

## SECTION FOUR: OTHER ORDINANCES NOT REPEALED

Nothing contained herein shall be construed or deemed to repeal or modify any other Ordinance or portion of any other Ordinance heretofore enacted and in force in the City of Lebanon Junction unless specifically repealed or modified by its explicit terms or by separate Ordinance.

### SECTION FIVE: EFFECTIVE DATE

This Ordinance shall take effect and be in full force upon passage and publication as required by law.
